WHAT: Northern Light Mayo will be transitioning certain **Flexitest** orders to general lab for **Quest Diagnostics**.

WHY: Quest Diagnostics offers collaboration with health systems to optimize laboratory services. This includes providing a broader test menu, cost-efficient service, and broad patient access. The update will also provide less time for providers entering Flexitests.

HOW: What's Not Changing?

- The ordering process for laboratory orders will not change.

- Please **remove Flexitest favorites** and **replace** them with the **orders** that are available **below**:
