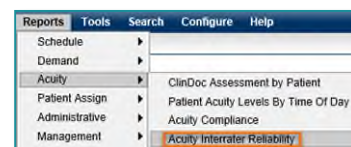


The Acuity Interrater Reliability Report evaluates the reliability between caregiver acuity assessments and an audit assessment. The report supports the audit process; an integral part of the acuity methodology measuring the degree of consistency in acuity assessments. Consistently accurate acuity assessments result in accurate workload measurements in Assignment Manager.

## Running the Interrater Reliability Report

➤ Hover over **Reports** in toolbar, then hover over **Acuity**, select **Acuity Interrater Reliability**.

- Enter the **Selection Criteria** for Facility and Profile.
- Update the **Start/End dates** to reflect the date of the assessment.
- Sort Patient Data by **Auditor**.
- If selections are being made the for the first time, the remaining fields may be left as defaulted.
  - Once filters have been applied, they will stay applied until changed.
- Select **Run Report**.

## Interpreting the Interrater Reliability Report

The report calculates percent agreement using absolute and near agreement comparisons.

- **Absolute Agreement:** Indicates the Likert ratings selected for an outcome match.
- **Near Agreement:** Indicates the Likert ratings for the outcome were within one value of each other.
- Interrater reliability is met for an outcome when the sum of the percent absolute agreement and percent near agreement is 85% or higher.
  - The average of NOC Outcomes should be **at least 86%** to confirm reliability of data.

**NOTE:** The report refers to EHR clinical documentation as assessment.

➤ **Summary Section:**

- **Total # Assessments Audited:** The total number of assessments audited for the selected location and service.
- **Total # Outcomes Audited:** The total number of outcomes audited for the selected location and service. The report displays by outcome set; each assessment audited has the same number of outcomes.

\* Correlation is the degree to which two or more variables are related and change together.

- N = The number of audited assessments in which the acuity level generated by the assessment and audit were identical.
- % = The percentage of audited assessments in which the acuity level generated by the assessment and audit were identical.
- **Assess Acuity > Audit Acuity N/%:**
  - N = The number of audited assessments in which the acuity level of the assessment was greater than the level generated by the audit.
  - % = The percentage of audited assessments in which the acuity level of the assessment was greater than the level generated by the audit.
- **Audit Acuity > Assess Acuity N/%:**
  - N = The number of audited assessments in which the acuity level of the audit was greater than the level generated by the assessment.
  - % = The percentage of audited assessments in which the acuity level of the audit was greater than the level generated by the assessment.
- **Acuity Level Correlation:** The correlation between the acuity level generated by the assessment and audit using a standard RSQ (r squared) calculation.

➤ Interrater Reliability for all NOC Outcomes in Audit:

- **NOC Outcomes:** The list of NOC outcomes in the defined outcome set being reported.
- **# Assess/Audit:** The number of times each outcome was assessed and audited, with each assessment/audit combination equaling 1.
- **Absolute Agreement:** Calculates the percentage of times the Likert rating for the assessor was identical to the Likert rating of the auditor.
- **Near Agreement:** Calculates the percentage of times the Likert rating for the assessor was not identical to the Likert rating of the auditor but was in one Likert rating.
- **Outcome Rating Correlation:** The correlation between the outcome rating generated by the assessment and audit using a standard RSQ (r squared) calculation.

➤ Assessments/Audits by Patient:

- **Assessed by:** The username of the person who completed the clinical documentation.
- **Audited by:** The username of the person who completed the audit assessment.

- **# of Outcomes:** The number of outcomes included in this outcome set.
  - **Weighted Average:** The average of the weighted raw acuity scores generated by the clinical documentation and the average of the weighted raw acuity scores generated by the audit.
  - **RN Acuity:** The acuity level calculated by the application from the clinical documentation.
  - **Audit Acuity:** The acuity level calculated by the application from the audit.
- Comparison of the **Assessment Likert Ratings** will display in different colors, depending on similarity. This makes it easier to view the differences between the assessment coming into Clairvia and the audit results.

- **Black:** Indicates an identical Likert Rating between the audit and the clinical documentation.
- **Blue:** Indicates a Likert Rating that differs by one value between the audit and the clinical documentation.
- **Red:** Indicates a Likert Rating that differs by two or more values between the audit and the clinical documentation.

**NOTE:** The report may be saved or printed by selecting the save icon or the printer icon.



- **Example:** Assume the outcome is Respiratory Status: Gas Exchange and the available Likert ratings are: Severely Compromised, Substantially Compromised, Moderately Compromised, Mildly Compromised, and Not Compromised.
- If **both** the assessor and the auditor select Substantially Compromised, the Likert ratings will show up in black on the report, indicating absolute agreement.
  - If the assessor selects Substantially Compromised and the assessor selects Moderately Compromised, the Likert rating is displayed in blue, because the values are one value apart, and thus indicate near agreement.
  - If the assessor selects Substantially Compromised and the assessor selects Mildly Compromised, the Likert rating is displayed in red because the values are more than one value apart, indicating nonagreement.

**NOTE:** A Clairvia Scheduling Work Request should be placed to request changes in Acuity mapping and scoring
