

From the Office of Health Informatics Clairvia Web Outcome Rating Summary Report July 2, 2025

The Outcome Rating Summary Report in Clairvia Web provides a summary of all completed acuity assessments by location and outcome set. The report displays the count and percent of Likert ratings (1-5) by outcome and location and can be used to identify gaps in documentation supporting acuity assessments.


Running the Outcome Rating Summary Report in Clairvia Web

- ➤ Hover over **Reports** in toolbar, then hover over **Acuity**, select **Outcome Rating Summary**.
 - Select **Facility** and **Profile**.
 - Update the **Start/End dates** to reflect the range to summarize.
 - Recommended selections:
 - Select Configuration: Show Current
 - Export Type: PDF
 - Select Run Report.


NOTE: Can select multiple Facilities or Profiles by holding CTRL key while making selections with mouse.

Interpreting the Report

- ➤ Header:
 - The report header begins with the **Profile Name**.
 - It may be followed by a location name and the hospital service if they are connected to the displayed outcome set.



- The **Configuration Date** is when the specific outcome set was implemented for the Profile.
- Summary Table
 - Weight: The weight assigned to the Outcome. The default weight value is 1.
 - Outcome Name: The NOC Outcome description
 - **Likert Rating Count**: The number of times the Likert rating has been selected for the outcome.
 - **Total # Assessments**: The sum of all completed assessments for the selected date range.
 - Likert Rating Percent: Percent of outcome assessments for each Likert rating.
 - Likert Rating Count ÷ Total Number of Assessments.

NOTE:

Likert ratings range from 1 to 5, with 1 being the worst (sickest) and 5 being the best (least sick). The 0 rating means that the clinical documentation interface did not process any documentation for that outcome.

Questions to consider:

- Does the report reflect the appropriate Likert scores for patients on the unit?
- If an outcome has a high **Likert Rating Percent** for the rating of 0 (no data), why might that be?
 - Does that outcome not always apply to most patients in this location?
 - The outcome **Electrolyte & Acid/Base Balance** is often mapped to lab values and not every patient has these labs ordered frequently during their stay. This is one outcome where "no data" would be expected.
 - Is the Clinical Documentation Interface capturing the right documentation?
 - Work with system support team to determine if the Observation/DTA mapping for the outcome is appropriate or if data is missing.
 - Provide additional training to caregivers on how their documentation is used for acuity assessments.
