

The Occupational Therapy Evaluation, Daily Documentation, Progress Note, and Discharge Summary forms in the Acute Adhoc folder have been replaced with Acute forms. Previously they were a copy of the Inpatient Rehab Facility (IRF) forms with Acute at the end of the name. The implementation of the Acute forms alleviates the printing issue with the IRF forms displaying more information than necessary.

#### ➤ Vital Signs

- Only **Orthostatics** will open a new section for documentation.

➤ **Special Tests Rehab**

- This section has been added to the forms.

➤ **Time Spent with Patient**

- **Start Time** and **Stop Time** have been added to the charge section to capture time spent with the patient.
- These are not mandatory documentation fields.

➤ **Home Environment**

➤ **Sections Removed from a Form**

- **General Information** has been removed from the **Discharge Summary** form.
  - This section contained a duplicate pain assessment documentation field that triggered the Pain Assessment to be redocumented.
- **Groups** has been removed from the **Daily Documentation**, **Progress Note**, and **Discharge Summary** forms.
- **Vestibular Exam** has removed from all forms.
- **Low Vision Functional Activities** has been removed from all forms.
- The following sections that are triggered from the **Vital Sign** section have been removed:
  - **Additional Measurement**
  - **Additional Vital Signs**
  - **Bilateral Blood Pressure**
  - **Home Readings**

- **Occupational Interests** has been removed from the **Evaluation** form.
- **Posture Deviations** has been removed from the **Evaluation and Discharge Summary** forms.
- **Cognitive Measures** has been removed from the **Evaluation** form.
