

# From the Office of Clinical Informatics Cerner Millennium Speech Therapy Acute Forms May 20, 2024

The Speech Therapy Evaluation, Daily Documentation, Progress Note, and Discharge Summary forms in the Acute Adhoc folder have been replaced with Acute forms. Previously they were a copy of the Inpatient Rehab Facility (IRF) forms with Acute at the end of the name. The implementation of the Acute forms alleviates the printing issue with the IRF forms displaying more information than necessary.

## **Adhoc Folder Structure**

The **Acute folder** is in first place allowing it to default open.

# **Section Changes**

- ➤ Home Environment
  - Lives With displays different options based on patient age.
    - Additional options to select from for patient's aged 13 and older display.
    - Patients ages 0-13, the form displays the options of Caregiver and Parents/Guardian.

# > Auditory Comprehension

• Smart template is no longer there to pull in previously documented data at the top of the section.

# > Cognitive/Communication

- Attention Grid
  - Alternating Attention and Divided Attention have had Attention removed.

### Time Spent with Patient

- **Start Time** and **Stop Time** have been added to the charge section to capture time spent with the patient.
- These are not mandatory documentation fields.
  - Alternating Attention and Divided Attention have had Attention removed.

### Sections that have been Removed

The sections being removed had minimal usage over a year and were not part of Cerner Model.

• Assessment has been removed from the Daily Documentation, Progress Note, and Discharge Summary forms.

- Group has been removed from the Daily Documentation, Progress Note, and Discharge Summary forms.
- BDAE (Boston Diagnostic Aphasia Examination Summary) has been removed from all forms.
- BNT (Boston Naming Test Summary) has been removed from all forms.
- **CLQT** (Cognitive Linguistic Quick Test Summary) has been removed from the **Daily Documentation** and **Progress Note** forms.
- RIPA-2 (Ross Information Processing Assessment -2 Summary) has been removed from the Daily Documentation and Progress Note forms.
- **RICE-R** (RIC Evaluation for Right Hemisphere Dysfunction Revised Summary) has been removed from the **Daily Documentation** and **Progress Note** forms.
- Oral Mechanism Exam has been removed from the Evaluation and Discharge Summary forms.
  - Documentation in Oral Mechanism Exam is duplicated in Oral Structure/Function.
