


Documentation of malnutrition is a joint effort between the Dietician and Provider. By providing a standardized location and content of malnutrition documentation, more streamlined communication between team members occurs. Hospitalists and Surgeons documenting in the Progress Note, Transfer Summary, and Discharge Summary will view the populated Malnutrition Assessment.

Malnutrition Assessment/Documentation

The Dietician completes the Malnutrition Assessment PowerForm using ASPEN criteria. Current Malnutrition Status and Malnutrition Plan auto populates to the provider's Progress note, Discharge Summary, and/or Transfer Summary with an attestation statement. The last charted value from the encounter for Malnutrition populates to the impacted note types.

➤ Malnutrition Criteria Met

- On creation of a **Progress Note, Transfer Summary, or Discharge Summary** the provider reviews the Malnutrition Assessment for the current malnutrition status and plan as documented by the dietitian.
 - In the **Progress Note** the assessment displays in the **Assessment/Plan** section of the note.
 - In the **Transfer and Discharge Summary**, the assessment displays in **Primary Problems and Follow Up Recommendations**, and the **Hospital Course** sections.
- Provider attests to the diagnosis statement by placing an **X** in the brackets.
 - By using the **F3** key, the cursor navigates to the bracket to place the **X**.



Malnutrition Criteria Not


- The dietitian's documentation of patient not meeting malnutrition criteria at the time of the assessment populates in the Progress Note, Transfer Summary, and Discharge Summary templates.

- The attestation statement does not appear on the template or final note. The attestation brackets appear and no action is required by the provider.



➤ Locating the Malnutrition Documentation

- The dietitian's completed **Malnutrition Assessment Form** is located in the **Documents** component on the provider MPage. Depending on the position, the Malnutrition Assessment is located in either the Consults, Consultations, or Admission and Consult Notes filter.



- The Malnutrition Assessment is located in the **Scales and Assessments** component of the provider MPage. The information is truncated due to character limitations. By highlighting the assessment, more information displays in the right-hand side of the component.
